#### 3. Finance

#### 3.1 Finance Update

APO Finance noted that the Finance Department is working on preparing the annual financial statements for 2022 and that the finance report for January/February will be presented at an upcoming board meeting.

#### 3.2 Draft Service Plan for 2023

DOSD noted that approval of the Service Plan is a reserved function of the Board, that a standard template is provided by the Department of Education and that the draft plan has been reviewed by the Finance Committee. DOSD outlined the main elements of the plan noting that it includes actions under LMETB's strategic goals as well as some as required by the Department. DOSD advised that projected expenditure is based upon Department and SOLAS communication as adjusted in the light of anticipated increases. DOSD thanked APO Finance and her staff for their input to the Service Plan.

APO Finance outlined the overall receipts and expenditure figures noting that receipts and expenditure of €227m are 19% and 24% respectively higher that 2022 actual. APO Finance also noted that capital expenditure represents the largest single expenditure heading.

The Chairperson of the Finance Committee, Mr. Sweeney, briefed members on the draft Service Plan for 2023 noting that the Committee reviewed the plan at its meeting on 17<sup>th</sup> February and resolved to recommend its approval by the Board. Mr. Sweeney noted that the plan proposes a substantial increase in expenditure and service and thanked all involved in its preparation. Mr. Sweeney noted that the Finance Committee is concerned at the fact that this increase in expenditure and service is not being matched by the necessary increase in allocation of staff. Mr. Sweeney expressed concern on behalf of the Finance Committee that this situation may hamper LMETB's ability to achieve its goals and targets and is likely to further increase demands on staff. Mr. Sweeney cited the fact that LMETB has not yet received approval to employ staff to run the new electrical apprenticeship centre in Drogheda. Mr. Sweeney also noted that organisational design (Phase 2) has yet to be addressed by the Department despite the fact that organisational design (Phase 1) was completed several years ago.

CE noted that boards of management and other committees of the board have important responsibilities including reviewing financial reports. CE therefore reiterated the importance of members receiving and monitoring financial reports. The Chairperson invited questions and comments from members.

Members thanked APO Finance and her staff for their work and commended LMETB on a significant planned increase in expenditure and service. Members supported the comments of Mr. Sweeney, Chair of the Finance Committee, regarding staffing levels.

A discussion took place regarding financial reporting at Board of Management and Committee meetings. DOSD and APO Finance confirmed that financial reports are issued to the Secretary of each Board of Management and requested members to alert them if financial reports are not being presented at meetings.

It was resolved **R. 03/02/2023** that financial reports be issued to the Chair of the Board of Management at the same time as to the Secretary.
