1. Order of Business

Ms. Kirk thanked the Chairperson for holding the meeting in the College and thanked the Chief Executive and Director of FET for their support in its establishment.

The Chairperson noted that a number are attending remotely via videoconference. In satisfying himself that a quorum existed, the Chairperson addressed the Board as a whole before the commencement of the business of the meeting and requested that all members in attendance remotely via videoconference identify themselves by turning their TEAMS cameras on. Where the Chairperson could not establish contact, or there was no response, he instructed that the account be removed from the meeting in line with standing orders.

Mr. Sweeney noted that there has not been an appreciable increase in staff numbers and expressed concern on behalf of the Finance Committee at this situation.

4.2.3. Approval of temporary, technical overdraft for O'Fiaich College, Dundalk

DOSD advised members that the bank account operated by O'Fiaich College is in the process of being closed and that, as part of the closing procedures, charges were applied to the account resulting in a temporary, technical overdraft of €30.40 for a period of eighteen days from 30th June to 18th July. DOSD advised that a lodgement was made on 18th July to return the account to credit and that it is anticipated that the account will be closed by 31st July.

DOSD noted that the power to borrow money is a reserved function of the board of LMETB as outlined in section 49 of the Education and Training Board Act 2013 and that the Board is invited to consider approving the temporary, technical overdraft.
