DOSD advised that approval of the temporary overdraft has been received from the Department of Education.

#### 5.3 Ratification of revised payments limits

Given the expanded operations, the transition of SAP to SUN where the creditors payments for RSTC will now be completed in the same creditors run as the rest of the LMETB creditors and the transition of monthly deduction payments to SUN LMETB is seeking an increase in the weekly creditors payment limit from  $\mathfrak{C}_{3m}$  to  $\mathfrak{C}_{6m}$  to cover payments in any single week up to  $\mathfrak{C}_{6m}$ .
