3.1 Finance Update

APO Finance took members through the finance report for 2023.

A discussion took place on the timeliness of presentation of school finance reports to Boards of Management. APO Finance described the process for issuing finance reports. Director of Schools confirmed that finance reports are issued monthly and asked members to contact her if they have concerns or queries.

A discussion took place on the cost of electricity, issues with billing by the provider and difficulties which one school is experiencing in managing electricity consumption. APO Finance advised that the billing issue is not confined to LMETB and that ETBs are engaging with the provider. DOSD advised that LMETB would follow up regarding the difficulties which the school cited is experiencing.

DOSD advised that projected expenditure is based upon Department and SOLAS communication as adjusted in the light of anticipated increases. DOSD thanked both APOs Finance and their staff for their input to the Service Plan.
